3) I will not hold the Figge Art Museum or Living Proof Exhibit responsible for any loss, damage, or repair to the artwork that has been accepted into the exhibition, and under no circumstances or conditions is my artwork insured for any purpose by the Figge Art Museum except where applicable under the Figge Art Museum's Commercial General Liability policy.

4) I understand that my artwork may be listed on my artist's vita as having been included in the Figge Art Museum's Living Proof Exhibit 2022.

5) I understand that my artwork may be used for purposes of publicity by the Figge Art Museum or Living Proof Exhibit.
